Colorado State Council Fall Board Meeting September 9, 2023 Salida, CO

President, Karen Addison asked Chaplain, Nancy Cameron for the Innovation then a delicious Continental Breakfast was served by our Alpha Omicron members.

President, Karen, called the meeting to order at 8:00 am and asked Chaplain, Nancy for The Thought Of The Day.

The Pledge of Aligence and the Opening Ritual were recited by all.

President, Karen welcomed everyone for coming and asked for Officer Reports as follows:

Chaplain, Nancy Cameron. Has sent Birthday cards, Thinking of You, Get Well and Sympathy cards on behalf of Colorado ESA and has attended memorial services of members. Nancy shares, by email, any news she receives, including the ESA International Chaplain's Newsletter. She wanted to emphasize that she wants to share GOOD news of Grand babies and accomplishments as well as health news. If anyone is not receiving these updates, or would like to be added to the email list, please contact Nancy and please keep her informed of news to share of members and their families.

Parliamentarian, Mary Humphrey, gave the Rules of Convention, asking everyone to please, silence their phones.

Corresponding Secretary, Jenniffer Carlson - Mazza Thanked those who got their change forms to her, but she only received **5 TOTAL!** She apologized if information is incorrect, but if she didn't receive a Chapter's Change Form by the deadline, she had to go with last year's information. Discussion about how to get those forms to the Corresponding Secretary on time took place with several suggestions for next year's President and Corresponding Secretary.

Treasurer, Bonnie Gillmore, wearing her "Treasurers" hat, introduced "Miss ESA Piggy". Miss ESA Piggy will be circulated at each State meeting to be fed PIN FINES. She's very hungry for Pin fines. Anyone not wearing their pin, needs to feed Miss Piggy \$1.00.

Bonnie then presented the Proposed Budget for 2023. (attached)

The beginning balance is not correct, as she has just received bills for Karen's I.C. expenses and needs to pay those first.

One Chapter, Zeta Rho #1774, Aurora has disbanded and the correct numbers are 20 Chapters, 221 Members and 4 Councils as stated on the report.

The Budget Committee, Karen Addison, Susan Bloss, Mary Humphrey and Bonnie Gillmore spent many hours trying to find expenses to cut. Their recommendations are posted in the Proposed column of the report.

Last year, the Budget Committee made some changes to try and cut down on expenses, but they were not made permanent in the Standing Rules. We will need to make those changes and the ones for this year to balance the budget.

Discussion: Rita Martin, Chi Kappa #5129, Denver - The room rate for the I.C. Convention is not enough to cover 5 nights lodging and should be increased.

Chloe McClantoc, Chi Kappa #5129, Denver - The Proposed income of \$3,272.00 and the Proposed expenses of \$3,276.40, does not balance. **Treasurer, Bonnie Gillmore** explained that Pin Fines will make up that difference and suggested an increase to the Pin Fines to \$2.00 when we vote on the Standing Rules.

Mary Humphrey, Beta Alpha #5416, Aurora - Please keep in mind that this is a PROPOSED Budget and some of these expenses may be less than what is allowed. This year's Proposed Budget is the closest we've come to balancing in many years.

Alice Robinson, Zeta Tau #2064, Colorado Springs - As a member of "Sustaining ESA Member", people may want to consider making a donation to the Colorado State Council and support our State as well. We have less and less people attending State meetings and that decreases our pin fine totals.

Mary Humphrey, Beta Alpha #5416, Aurora - Believes having a State Fund Raiser is a really good idea.

Karen Addison, Zeta Nu #5608, Colorado Springs - Since the biggest cost of the State Yearbook is printing and mailing, maybe stop printing extras, for sale. It is on the web site and can be printed.

Leslie Stevens, Kappa lota #5442, Golden - The Yearbook can also be sent via email. Also, maybe print the "guts" only and NOT put them in folders. That would reduce the costs, as well.

Mary Humphrey, Beta Alpha #5416 - We should add a line item to income for donations/fund raisers. Also, the Lamplighters paid \$80.00 for their yearbooks, thus the cost this, years was reduced. This will continue into to future.

Leslie Stevens, Kappa lota #5442, Golden - If we wanted to specify where a donation should be applied, can we do that?

Treasurer, Bonnie Gillmore - Yes! That can be done.

Treasurer, Bonnie Gillmore summarized changes to the Proposed Budget as follows:

Add a line item for donations to income Reduce the State Yearbook budget from \$185 to \$100. Increase the Int'l Convention Lodging budget for the President from \$350 to \$500.

Alice Robinson, Zeta Tau #2064 moved to accept the Proposed Budget as amended.

Chloe McClantoc, Chi Kappa #5129, Denver seconded.

President, Karen asked for a voice vote. Motion Passed.

Recording Secretary, Leslie Stevens moved to dispense with the reading of the CSC Minutes from State Convention as approved by The Minutes Review Committee and posted to the Colorado ESA Web site.

Coming from a committee a second is not required.

President, Karen asked for any discussion. There being none, she called for a voice vote. Motion Passed.

President - Elect, Susan Bloss - Looking for people to fill offices for the 2024 - 2025 State Council. Currently we have the following positions filled:

President - Susan Bloss
President - Elect - Lori Anderson - Havelick
Sr. Past President - Chloe McClantoc (Awards)
Jr. Past President - Karen Addison (Disaster Fund)
Corresponding Secretary - Dana Bell
Recording Secretary - Susan Winton

We still need a Vice President and the myriad of all the other offices that need to be filled. Please, if you would like to hold an office or have questions about offices, reach out to Susan.

Susan has sent out an email to all Officers asking for recommendations for their Offices to pass on to the next Officer. She is working to get those updated and current.

Guidelines Committee - Susan Bloss There was some discussion that the Guidelines Committee last year did a lot of changes, but it is also really good that Susan is looking at them again and, hopefully, adding to them. Susan asked who updated the Convention Book that is supposed to be passed on. There was much discussion and the conclusion was that the Convention Book should be in a centralized area, so everybody could look at what's required to hold Convention. The 2023 - 2024 Convention Hosts should have the book and Susan will contact them and see if she can get it. It was also recommended that it is posted on the web. Mary Humphrey, Alpha Beta #5416, Aurora, The Convention guidelines ARE on the website under Guidelines. They were posted there a couple years ago. The Guidelines were reviewed last year, by Pam McGee's Committee. Updates were made as a result of Bylaw changes and posted on the web site. Guidelines are ONLY changed if there are Bylaw changes or policies by Headquarters.

Vice President - Lori Anderson - Havelick Is looking for bids for the 2024 - 2025 and 2025 - 2026 State Conventions. She feels we need to talk about State Convention going forward for new ideas, as we are getting less and less members to come and costs are getting higher.

The 2023 - 2024 State Convention will be in Colorado Springs with Zeta Tau #2064 and Zeta Nu #5608. If you are interested in hosting the State Convention, or have questions about doing so, please contact Lori.

Lori also wanted to discuss a new program by Headquarters called "The Power Of US"! This was presented by our Executive Director, Charlotte Carloni, at I.C. Convention. The Power Of US campaign focuses on the power of what ESA does and IS! This campaign, is for participating in the three areas of our organization. Education, Service and Association. It is also a FRIENDLY competition! Chapters should Strive to share our story, through presentation or any other means, of the good works ESA does and has done throughout the world. Chapters are invited to enter projects, in each of the three categories, to add to our National story. More information on this campaign can be obtained at www.epsilonsigmaalpha.org/PowerOfUs. Lori encouraged all Colorado Chapters to participate.

Membership is in the Power of Association category. This year's activities are for both Recruitment and Retention. Think about having a new member party or some type of FUN recruitment gathering. - **SR 4:** Clarification: The Committee determined the wording, "Non Presidents" to sound a bit derogatory. **PASSED**
- SR 5: Change verbiage to update our State with International terminology (sorority to ESA pin)
 Chloe McClantoc, Chi Kappa #5129, Denver, proposed to Amend the change to read: Members not wearing their ESA pins at State Council meetings will be fined \$2.00 (Two Dollars) with the proceeds going to the State Treasury.
 Alice Robinson, Zeta Tau #2164, Colorado Springs, Seconded

President, Karen asked for a voice vote on the **Proposed Amendment. PASSED**President, Karen asked for a voice vote on the **Proposed SR change as Amended. PASSED**

SR 6: Leslie Stevens, Kappa lota #5442, Golden; there needs to be something in our SRs stating that upon submission of an itemized bill and approval of the CSC Executive Board, an Officer may be reimbursed for expenses.

Dana Bell, Zeta Tau, #2164 Colorado Springs **Proposed to Amend**; All elected and appointed Officers may be reimbursed for expenses upon receipt of an itemized bill and approved by the Executive Board. Delete A & B and combine into ONE, **SR 6**.

Jenniffer Carlson- Mazza, Alpha Omicron #770, Salida Seconded

President, Karen asked for a voice vote on **Proposed Amendment**. **PASSED**President, Karen asked for a voice vote on **Proposed SR change as Amended**. **PASSED**

SR 7A: PASSED

SR 7B: Many were sad to see the tradition end. Chapters could fund this if they wanted to. PASSED

SR 7C: PASSED SR 7D: PASSED

SR 7E: PASSED SR 7F: PASSED SR 7G: PASSED SR H2: PASSED SR 8: PASSED SR 9: PASSED SR 11B: PASSED SR 11C: PASSED

SR 13D: Much discussion as to whether **partial registrations** should be accounted for in the **SRs**. Discussion switched to who is responsible for the Convention Guidelines and who updates them on the Web site.

POINT OF ORDER called by Nancy Cameron, Kappa lota #5442, Golden; We are getting into the weeds of the Convention book chain of process and that is not the stated Standing Rule change currently on the floor. **SR 13D is on the floor.**

Nancy Cameron, Kappa lota #5442, Golden proposed to amend SR 13D to read:

Preparing a report to be given at the 2nd General Assembly, to include the total number of persons registered at convention, with the breakdown of Members, Members At Large and guests. (Delete **Full registrations** from the Proposed Change, so that partial registrations can be utilized and counted in the report)

Pam McGee, Gamma Chi #3668, Loveland, Seconded.

President, Karen asked for a voice vote on the Proposed Change as Amended. PASSED

SR 13E: Much discussion regarding chain of process of the Convention Committee books and Guidelines. Should be reviewed each year and ensure it gets to the Web site. WHO is responsible for updating the Convention Guidelines? Traditionally, the Host Convention City, passes on the "book" to the next Convention City, but this apparently is not happening. There doesn't appear to be a clarified chain of process and ownership of the Convention Guidelines and Book.

Dana Bell, Zeta Tau #2164, Colorado Springs, suggested rewording the change to specify the Convention Guide Book on the Web Site, should be updated by the Convention City.

Susan Bloss, Zeta Tau #2164, Colorado Springs, suggested that 13E should be deleted, as Proposed, until the Guidelines Committee can determine the chain of process. It can be added back in at any time to the Standing Rules once that has been determined.

President, Karen asked for a voice vote on the Proposed Amendment. PASSED

SR 14: Chloe McClantoc, Chi Kappa #5129, Denver. Some wording was omitted from the Proposed change. Chloe Proposed an Amendment to read:

Prior approval must be obtained from the Convention Chairman for any **items being sold or drawings** to be held at the State Convention and such activity shall be confined to a designated area.

Leslie Stevens, Kappa Iota #5442, Golden, Seconded.

President, Karen asked for a voice vote on the **Proposed change as Amended. PASSED** President, Karen, asked for a voice vote on the **Proposed Amendment. PASSED**

Add New SR: Bank fees PASSED

- **Sr. Past President/ Awards Chair Pam McGee** Reports are due to her by April 1st. Pam would like Chapters to really consider sending in reports for Outstanding Chapter, Distinguished Athenian, Outstanding Pledge, Outstanding Woman and Pioneer Woman. These are also due by April 1st. For Years of Service Awards, they are due by May 1st. More will follow in the next Golden Lamp
- **Jr. Past President/ Disaster Fund Chloe McClantoc** reported that at IC Convention this year, the total amount someone could apply for through the Disaster Fund was increased from \$5,000 to \$8,000.

COLORADO STATE COUNCIL PROPOSED STANDING RULES Fall Board 2023

SR 1: **Currently reads:** Standing Rules may be amended or rescinded by two-thirds (2/3) vote of the General Board.

Passed - Proposed to read: Standing Rules may be amended or rescinded by a majority of

members present.

Reason for change: To agree with the voting in the By-Laws, Article XIII, Section 6.
