ESA Foundation Mission: "Established in 1970, the ESA Foundation is dedicated to the promotion of continuing education and to altruistic activities that make a positive difference in the world community. Voluntary contributions of time and money from ESA members, ESA Foundation members, and friends of the Foundation are the ESA Foundation's sole sources of support. As a nonprofit, tax exempt corporation, the ESA Foundation supports the service and leadership programs and the philanthropic projects of Epsilon Sigma Alpha International."

Hello Friends. In our August 2024 ZOOM ESA Foundation Counselor Training, we covered our Purpose, Duties, Resources, Credential Process, Scholarships, Endowments, Grants, Planned Giving Program, Pathway Program, Turnaround Funds, 2025 Director Nominations (nomination forms returned by October 1st), Membership Dues and Communications. As our CSC ESA Foundation Counselor, I have 2 major goals this year: 1) as a Life Active Member myself, to learn even more about ESA Foundation to be able to guide/answer questions and 2) to increase/encourage ESA Foundation membership in ESA Colorado.

Yes, I'm also encouraging "homework"/reading on your own, as there is excellent detailed readily available information online. I'm editing/summarizing as much as possible here, as there is so much wonderful information about ESA Foundation that is continuously being updated. I highly recommend reading the current ESA Foundation Fall Newsletter via: Newsletters, as well as watch videos of workshops too.

Coming up by December 31st, Membership Dues. In my August 2024 the Golden Lamp article, I shared from Ann Southall - ESA Foundation Vice Chairman, how to become a member of ESA Foundation. A quick summary: our ESA Foundation annual dues are to be paid by December 31st of each year. \$40 per Member and \$40 per Chapter. For a Life Active Membership, it is a one-time \$500 donation or 2 \$250 donations. In order to vote for board members, etc.- active members must have their annual dues paid before December 31st. ESA Foundation membership renewal is coming up, so please watch your email in early November for your renewal notice. ESA Foundation prefers we pay our annual dues beforehand or as soon as we get their notice, so they will not need to send a follow-up reminder by US mail. All monies go directly to the ESA Foundation office. Here is the link:

<u>Credential Process</u>: Credentials are managed electronically, so there is no need to get proxy signatures and distribute ballots. Voting: More info from ESA Foundation Vice Chairman, Ann Southall, "Voting for ESA Foundation elections will be held electronically. To be sure you receive your ballot, it is important that your current email address is on file. To check your email address, go to the ESA website (https://epsilonsigmaalpha.org) and log into the member center and check the address listed on your profile. Votes for chapters, councils and other entities will be sent to the email address of the person listed as President for that chapter/entity. Members who have opted to not receive emails from the ESA Foundation, and who want to receive a ballot, should contact ESA Headquarters and provide an active email address."

<u>Scholarship</u> applications will be accepted September 1, 2024 through 11pm MST on January 31, 2025. Since ESA Foundation is a public Foundation, the scholarship program is open to everyone, including non-ESA members, ESA members, their relatives and friends, etc. If you, or someone you know, will be attending any level of college—please visit the ESA Foundation Scholarship page to see the scholarships available and to start an application.

https://www.epsilonsigmaalpha.org/scholarships Please share/publicize https://epsilonsigmalapha.org/about/ESAFoundation in your Chapters, Work and everywhere.

Quick information regarding the applications. First, the applicant will need to create a scholarship account. Once completed, there will be suggested matches for the applicant, and they will be able to check progress to complete requirements on any of the scholarships for which they are applying. For example, monitoring receipt of recommendation letters and transcripts requested using the scholarship account. Note - there is no fee to create an account and begin searching for scholarships, but there is a \$5.00 processing fee for each scholarship applied for, although one current transcript may be submitted to cover all of the applications. Kathy Lloyd is the Scholarship Chaiman.

<u>Endowments</u> are what fund the Scholarships. Notes from our August training: last year 14 scholarships for \$14k were not awarded due to not receiving applications. As of January 1, 2024 of the previous Scholarship season, there were 33 scholarships that had not received applications. If wanting to create a new endowment or make changes to an existing endowment, Judy King is the Endowment Chairman

Grants: There are 3 Grants that we talked about in our Training:

- -The Career Enhancement Grants are designed to help applicants attend workshops and seminars that help them increase their job ability or knowledge in their current field of employment or assist them in starting a new job. Application money request is for Registration fees and actual materials needed to attend and study for the event. Travel and hotel accommodation costs are not included in this grant request.
- -The Vocational Training Grants provides opportunities to applicants seeking to develop skills for a new career or to enhance their skills and knowledge for further advancement in their chosen career field.
- -The Partnerships/Joint Venture Grants are to support other nonprofits who provide educational career training programs that meet the ideals and goal of the ESA Foundation or to support larger grant making entities who can support multiple clients for a single program that furthers the educational interests of the ESA Foundation. NOTE: Currently this grant is not available as the ESA Foundation has committed funds until 2024 to support the St. Jude Graduate School of Biomedical Sciences

<u>Planned Giving Program</u>: Donating to the Foundation in a Will or as a Beneficiary to an Insurance Policy. New Planned Giving pamphlets are available from Kathy Loyd, Planned Giving Chairman

<u>Pathway Program</u>: a new program for the Foundation that was announced at the 2024 IC Convention: <u>Pathway – Epsilon Sigma Alpha (ESA) – An International Service Organization</u>, was created to celebrate special ESA Foundation or ESA members, Community Volunteers, or other Special People with your gift to the Pathway Program. Your donations will pave the way to a brighter future for our organization, those who follow in our path, and all we serve. Flyers are available from the webpage or contact Jennifer Sparkman via email: jmsparkman7@gmail.com, who can mail hard copies of the flyer.

Last but not least, <u>Turnaround Funds</u>: (below copy and pasted from our ESA Foundation Counselor Training)

- -Important to the Foundation to help strengthen 501c3 status
- -Rather than sending individual checks to one or more 501c3 charities, the individual sends one

check to the Foundation indicating which charity is to receive what amount. The Foundation turns around this request and sends individual checks back to the person using the turnaround funds. Then the person sends the checks to the individual charities.

- -Benefit: Easier to document donations on your taxes (donations to one charity instead of multiples)
- -Item to remember: Checks are returned to the donor, not the charity, so the donor needs to send them on to the charity.
- -Headquarters has asked that we complete one turnaround form and send one check for every 10 organizations listed. This allows them to process the entries in the system without it timing out.


